Good Mojo Dog Center

As a condition of using our services and/or our facilities, the following form must be read, agreed to and signed.

I hereby declare to Good Mojo Dog Center, LLC (herein referred to as Good Mojo) that I am the legal owner of my pet(s); that my pet(s) have not been exposed to any other communicable diseases within the past (30) thirty days; that my pet(s) have been inoculated as indicated by records presented; and that I (the owner) have read this agreement in its entirety, accept all terms, rules, requirements, conditions and statements of this agreement.

On behalf of myself and any and all other owners of these pet(s), I have read and agree to the terms of this contract. I warrant that I have the authority to represent any and all other owners of these pet(s) in signing this contract.

Financial

I agree to pay all fees daily and that I am responsible for all fees for my pet(s) at Good Mojo including for regular products and services, late pickup fees, cancellation charges, bank fees associated with returned checks, veterinarian fees incurred while my pet(s) are at Good Mojo, damage to property, or any other reasonable fee associated with my pet(s)' care.

I understand I am solely financially responsible for veterinarian fees associated with any illness or injury resulting from my pet(s) time at Good Mojo.

I hereby certify that any credit card numbers or related information I have provided to Good Mojo are valid and current. I hereby authorize Good Mojo to charge against said credit card any and all valid and appropriate fees and charges owed by me including veterinary charges, flea baths should my pet(s) be found to have fleas or ticks, etc.

I understand that discounted packages are provided only if they are paid for in advance. **Pre-paid packages are non-refundable and expire 6 months from the date of purchase.** Our program is flexible enough to accommodate special needs requests.

Good Mojo Rules and Requirements

Dogs must be at least 5 months and be neutered by 7 months to participate in any group play program.

I will keep my dog on leash in Good Mojo's lobby, parking lot and surrounding property.

I agree to disclose to Good Mojo if my pet(s) have harmed or shown aggression or threatening behavior towards any person or other pet(s); or if at any time my pet(s) becomes ill or contracts any communicable condition.

I agree to wait at least 48 hours after applying topical flea and tick medication before coming back for any group play experience at Good Mojo for the safety of all pets.

All dogs presented for group play must undergo an evaluation for their compatibility with Good Mojo's program. Evaluations are ongoing and I understand that Good Mojo reserves the right to remove a dog from group play programs at any time, for any reason.

Liability and Waiver

If my pet(s) participates in daycare, grooming, training, boarding or playgroup, I understand that any socialization of pets is not without some risk of illness or injury, that despite all the pets appearing healthy and being handled with care and foresight, pets are not always predictable and the unexpected may occur. I recognize that the benefits utilizing Good Mojo's services are valuable to my pet(s), and accept the potential risks such as illness, scratches, punctures, torn ligaments, or other injuries. I understand that, just like bringing my children to kindergarten, by socializing my pet(s) I am exposing my pet(s) to the potential for communicable diseases resulting in potential illness. I understand that even though Good Mojo is vigilant in disinfection protocols and does its best to lower the risk of such illness, snout to snout contact and airborne illnesses (such as kennel cough) can never be fully prevented.

I will not knowingly bring any pet(s) with a contractible illness to Good Mojo's facility,

If my pet(s) appears to be ill or injured I authorize Good Mojo to engage the services of a veterinarian at my expense, to give other requisite attention, and to make whatever decisions are required for the pet's veterinary treatment. I agree to pay all veterinary charges incurred by my pet(s) while in the care of Good Mojo. I will not hold Good Mojo liable for failure to seek veterinary attention or for decisions made under this section.

I understand that Good Mojo will exercise all reasonable diligence and care in the guardianship of my pet(s). I hereby waive and release Good Mojo, its employees, owners and agents from any and all liability of any nature, for injury or damage or elopement, including that which may result from the action of any pet(s) including my own, and I expressly assume the risk of such damage or injury, including personal injury to me or my property, while my pet(s) and/or I participates in or attends any function or service of Good Mojo, while on the grounds or the surrounding area thereto.

I understand and agree that Good Mojo, its employees and volunteers will not be liable for any loss of my pet(s) due to fire, theft, death, injury or elopement and I hereby agree to hold harmless Good Mojo from any all claims for such losses unless due to the gross negligence of Good Mojo or its employees.

I hereby indemnify and hold harmless Good Mojo for any and all injury or damage done by my pet(s) to other pets, people, including employees and guests of Good Mojo, or to any property regardless of the owner of said property. I agree to be responsible for any injury caused by my pet(s) to other pets or to any person, including but not limited to, staff of Good Mojo Dog Center, clients customers or visitors.

I understand that if my pet(s) is not picked up within seven days of the appointed time, the pet(s) may be considered Abandoned under New Hampshire RSA 438:18-20.

Boarding old, very young, chronically ill or otherwise debilitated pets requires special care, which Good Mojo's caring and trained staff is happy to provide. However, special-needs pets, puppies and senior pets naturally have a higher risk of injury, stress related illness, or exacerbation of any pre-existing conditions. As such, by leaving my special-needs pet(s), puppy (puppies), or senior pet(s) in Good Mojo's care I am waiving any claim for injury or illness experienced by my pet(s) that is not directly caused by negligence or lack of care on the part of Good Mojo staff.

I agree to allow Good Mojo to release photos and videos of my pet(s) on social media or other marketing materials.

I agree not to hold Good Mojo responsible for any loss or damage to personal property including bedding, leashes, collars, etc.

Full Force and Effect

I further understand and expressly agree that each and every of the foregoing provisions in this form shall be in full force and effect and shall apply to each and every occasion on which my pet(s) participates in a Good Mojo service or otherwise visits Good Mojo property. This Agreement shall remain in full force and effect as between the parties (myself and Good Mojo Dog Center, LLC) until and unless otherwise cancelled or superseded by a writing signed by both parties.

I hereby certify that I have read and understand this Agreement, Waiver and Release of Liability and the regulations set forth above. By signing this agreement, I agree to be bound by its terms and conditions.
